SECTION 1: Identification of the substance/mixture and of the company/undertaking

1.1 Product identifier

Recommended use: Laboratory chemicals. For scientific research use only.
Uses advised against: Not for human or animal use, consumption, therapeutic, diagnostic or medicinal purposes. Not intended for food, cosmetic or household use.

SECTION 2: Hazards identification

2.1 Classification of the substance or mixture

Classification according to GB CLP Regulation: The mixture is not classified as hazardous under GB CLP on the basis of the low concentration of benzyl alcohol (0.9% w/v), which is below the generic concentration limits that would trigger classification of the mixture for acute toxicity, eye irritation or skin sensitisation. However, the presence of benzyl alcohol is noted and appropriate laboratory precautions should still be observed.

2.2 Label elements

No hazard pictogram, signal word, hazard statement or precautionary statement is required for the mixture according to available data and concentration limits. Users should still avoid contact with eyes and prolonged skin contact.

2.3 Other hazards

This substance/mixture does not meet the criteria for PBT or vPvB. No other hazards known under normal laboratory handling conditions.

SECTION 3: Composition/information on ingredients

3.2 Mixtures

SECTION 4: First aid measures

4.1 Description of first aid measures

Inhalation: Move to fresh air. If symptoms develop, seek medical attention.
Skin contact: Wash with soap and water. Seek medical attention if irritation develops.
Eye contact: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing.

Ingestion: Rinse mouth. Do not induce vomiting. Seek medical attention if feeling unwell.

4.2 Most important symptoms and effects

None reasonably foreseeable under normal laboratory handling conditions.

4.3 Indication of any immediate medical attention

Treat symptomatically. No specific antidote known.

SECTION 5: Firefighting measures

5.1 Extinguishing media

Suitable: Water spray, CO₂, dry chemical, foam. **Unsuitable:** None known.

5.2 Special hazards

Thermal decomposition may produce carbon oxides, nitrogen oxides and (where applicable) copper oxides.

5.3 Advice for firefighters

Wear self-contained breathing apparatus and full protective equipment.

SECTION 6: Accidental release measures

6.1 Personal precautions

Avoid dust formation (or aerosol formation for liquids). Wear PPE (see Section 8). Ensure adequate ventilation.

6.2 Environmental precautions

Prevent entry into drains or watercourses.

6.3 Methods for cleaning up

Absorb with inert material. Place in labelled container for disposal. Clean area with water.

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Handle in accordance with good laboratory practice. Avoid contact with skin, eyes and clothing. Avoid inhalation of dust or mist. Wash hands after handling.

7.2 Conditions for safe storage

Store in a tightly closed container in a dry, cool place. Protect from light and moisture. Recommended storage: 15–25 °C (room temperature); do not freeze. Keep away from strong oxidising agents.

7.3 Specific end use(s)

For laboratory research use only.

SECTION 8: Exposure controls/personal protection

8.1 Control parameters

No occupational exposure limits established for the peptide components.

8.2 Exposure controls

Engineering controls: Use in a well-ventilated area or fume hood if generating dust or aerosols.

Eye protection: Safety glasses with side shields (EN 166).

Hand protection: Chemical-resistant gloves (nitrile, EN 374).

Skin protection: Laboratory coat.

Respiratory protection: Not normally required. Use particulate filter (P2) if dust is generated.

SECTION 9: Physical and chemical properties

9.1 Information on basic physical and chemical properties

Physical state: Liquid (clear, colourless aqueous solution)

Colour: Colourless

Odour: Odourless or nearly odourless

Solubility: Soluble in water (typical for research peptides/compounds)

Other properties: Melting point, boiling point, flammability, pH, viscosity – no data available or not applicable.

SECTION 10: Stability and reactivity

10.1–10.3 Reactivity / Chemical stability / Hazardous reactions

Stable under recommended storage conditions. No hazardous reactions known under normal use.

10.4 Conditions to avoid

Excessive heat, moisture, prolonged light exposure, strong oxidising agents.

10.5 Incompatible materials

Strong oxidising agents, strong acids and bases.

10.6 Hazardous decomposition products

Carbon oxides, nitrogen oxides (and copper oxides where applicable) under fire conditions.

SECTION 11: Toxicological information

11.1 Information on hazard classes

Acute toxicity, skin corrosion/irritation, serious eye damage/irritation, respiratory or skin sensitisation, germ cell mutagenicity, carcinogenicity, reproductive toxicity, STOT-single/repeated exposure, aspiration hazard: No data available for the mixture. Individual peptide components have limited toxicological data available.

11.2 Information on other hazards

To the best of our knowledge, the chemical, physical and toxicological properties have not been thoroughly investigated. Handle with appropriate laboratory precautions.

No data available.

12.5 Results of PBT and vPvB assessment

Not considered PBT or vPvB.

13.1 Waste treatment methods

Not classified as hazardous under GB CLP (or classified only for components present at low concentration). Supplied for research and development purposes in accordance with UK REACH.

Note on Benzyl Alcohol: Benzyl alcohol is a known preservative that can cause allergic skin reactions in sensitised individuals and is harmful if swallowed in concentrated form. At 0.9% the mixture itself is not classified, but good laboratory practice requires avoiding unnecessary exposure.
